NOTICE

In the context of Covid -19 pandemic, the school has already allowed concession to the extent of enhancement of fee made during the year 2020-2021 over the fee of the previous year (2019-2020) vide Notice No.DAV (UNIT-VIII)/994/2020, dated 15.07.2020. Further, in pursuance of the orders of the Hon'ble High Court dated 07 January 2021, Govt. Notification dated 19 January 2021 and orders passed by the Hon'ble Supreme Court in SLP(C) No.3355/2021 dated 18.03.2021, the school has allowed additional concessions vide Notice No. DAV (UNIT-VIII)/459/2021, dated 20.03.2021. **The school has once again considered the issue in the context of the orders passed by the Hon'ble Supreme Court dated 03.05.2021 and subsequently Notification No.10215/SME, dated 03.06.2021 of School and Mass Education Department, Govt.of Odisha and has now decided to allow the fee concession for the year 2020-2021 as follows and If, as a result, any refund/adjustment is due, it will be adjusted against the school fee of 2021-2022 in equal instalments deducting from the quarterly fees payable for each quarter.**
