Inviting reference to the circular of CBSE/Acad./2026 dated 09.04.2026, regarding introduction of R3 in class-VI, as per the new scheme of studies 2026-27, the students from class-VI onwards must study three languages i.e R1,R2, and R3 till class-X.As the medium of instructions in our schools is English. English is R1 (Language 1). In view of importance of the Regional Language in NEP-2020, and availability of facilities in the school, R2 & R3 will be either Hindi or Odia or Sanskrit. It's further informed that the subject opted as R3 language in Class-VI, will continue till Class-X and the same will be uploaded in the OASIS Portal of CBSE by 30 April, 2026. No changes shall be allowed in case of R3 till class-X. However, it is suggested that the domiciles of Odisha must choose Odia either as R2 or R3 so as to ensure their future prospective in various Govt. of Odisha Services. You are aware that study of Odia is mandatory for the same.
